RELEASE OF LIABILITY AGREEMENT

The borrower is solely responsible to acquire appropriate insurance for the use of the borrowed equipment. The borrower is solely responsible to implement liability shields (ie. waivers, release of liability agreement, warnings, labels, limitations such as height/age/weight/medical/user experience restrictions) to ensure the safety of users and protection of the borrower. The borrower is responsible to use applicable devices such as stakes and ties in order to secure the equipment and safety of users. The borrower agrees to hold harmless and defend MGA and all of its agents from any third party claims that arise out of or in connection with the use of the borrowed equipment during the borrowing period. In the event that any legal defense of MGA is required, the borrower shall assume all legal costs and expenses associated with the claim. **I AM AWARE THAT THE MGA BORROWED EQUIPMENT MAY LEAD TO PHYSICAL ACTIVITY, AND AM VOLUNTARILY ALLOWING guests to PARTICIPATE IN SUCH ACTIVITY WITH THE KNOWLEDGE OF ANY DANGER INVOLVED. I INDEMNIFY MGA AND ACCEPT ANY AND ALL RESPONSIBILITY OF ANY RESULTING DAMGES, LOSSES, AND INJURIES TO USERS.** In exchange for my allowing guests to use the borrowed equipment, I agree that I **WILL NOT SUE OR MAKE A CLAIM AGAINST MGA** for any injury or damage resulting from this use and will assume full responsibility for any loss arising from the borrowing period.
